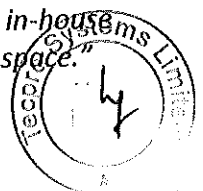
### **Tecpro Systems Limited receive orders worth Rs. 269.2 crore from Bhartiya Rail Bijlee Company Limited for Nabinagar Thermal Power Project**
