Tecpro Systems Limited receives Coal Handling Plant Packages worth ₹ 208.6 crore from Lanco Infratech Limited

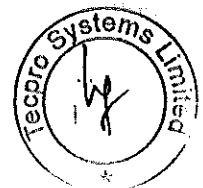
- Order for 3 x 660 MW Lanco Koradi Thermal Power Plant, Maha GENCO worth ₹ 167.0 crore

Commenting on the development, Mr. Amul Gabrani, Vice-Chairman & Managing Director, Tecpro said, "We are very happy to announce these orders which we have bagged in the Coal Handling space.
