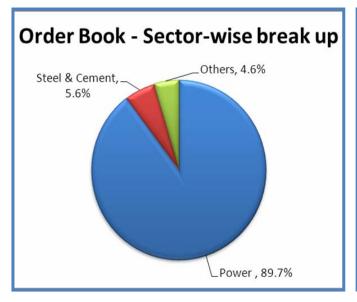

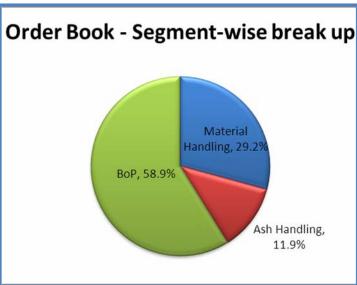

Gurgaon, February 09, 2011:Tecpro Systems Limited (Tecpro), a key player in the material handling sector, providing turnkey solutions in material handling, coal and ash handling, Balance of Plant (BoP) and which undertakes Engineering, Procurement & Construction (EPC) contracts in the power sector, has announced its results for the third quarter and nine months ended December 31, 2010.

Order Book Details

- Strong order backlog of ₹4,250 crore providing revenue visibility of the order of 2.9x FY10

The next year looks even more exciting with our continuous efforts on enhancing our order portfolio with larger orders, bidding profile and projects under execution. The consistent growth in our Order Book position is a result of our performance track record and ability to successfully market our services to existing and new clients. We are well positioned to avail the abundant growth opportunities going forward and are confident of maintaining a growth of 30% - 35% in revenues as well as profits over the next two years."

Operational Review

Tecpro posted a healthy performance this quarter with sales revenues at ₹ 1,012 crore, up 40% Y-o-Y mainly accruing from the BoP, Coal Handling and Ash Handling businesses.

Net profit stood at ₹ 26.5 crore representing 40% increase over the same period last year.

The company also forayed into the EPC segment for thermal power projects in 2007, in which it managed the erection and commissioning of the boiler, turbine and generator (BTG) packages along with undertaking the engineering, design, supply and commissioning of other equipment and services. Leveraging its capabilities in coal and ash handling, the Company has also taken up turnkey BoP contracts in the thermal power generation sector. The business undertaken by the company broadly comprises four segments viz. material handling solutions, ash handling solutions, BoP/EPC contracts and other businesses such as supply of air pollution control equipment.
